A completed "e-mailed" application would be acceptable if the \$250.00 filing fee is made by the deadline, and a signed hard copy is presented at the time of review.

Members of the Board of Directors will review all applications.

All persons submitting applications MUST attend the Candidate Review meeting for review of their applications. The meeting will be scheduled and communicated at the January board meeting. Failure to appear at this meeting will void your application. Falsification of any information on the application will result in rejection of the applicant without refund of the filing fee.

If this application, upon review, is accepted, there will be no refund in full or part, should the applicant for whatever reason, withdraw from the election. NO REFUNDS WILL BE GIVEN TO APPLICANTS WHO DO NOT WIN DURING THE ELECTION. If this application, upon review, is rejected for any reason other than the one stated in Paragraph #4. the applicant will receive a full refund of their fee at the review meeting.

**Campaigning will begin at King of Hearts function, TBD Feb or Mar 2025. Any campaigning done before then will result in immediate termination of candidate's candidacy.**

Campaigning is PROHIBITED within three (3) city blocks of the voting area. There will be one (1) poster allowed within the voting area.

Candidates are allowed only one (1) function during campaign, either produced by the candidate or on his/her behalf, and one (1) joint function sponsored by all the candidates. Most of the candidates will be the deciding vote for the number of functions to be held.

The final vote tally authorized by the voting authority WILL BE FINAL. THERE WILL BE NO RECOUNTS ALLOWED.

The RMCS will not be held responsible for ANY monies or prizes advertised or promised by the candidates or their staff. As a candidate of the RMCS, campaign functions are benefits for viable charities using the RMCS name and title of candidate for Emperor or Empress. Net profits of campaign functions will be assessed the usual 20% administrative fee for the RMCS events.
